Statutory information in accordance with Italian data protection legislation (Art. 13 D. Law 196-30 of June 2003) and declaration of consent to data treatment

Information and agreement regarding consent to the treatment of data necessary for processing applications for certification, and membership, as well as administrative, accounting, commercial and legal activities and/or assistance, entered into between the undersigned and REGISTRO FIAT ITALIANO and REGISTRO ABARTH.

With reference to Legislative Decree no. 196 of the 30th June 2003, published in the supplement to the Gazzetta Ufficiale no. 124 of 29 July 2003, regarding the new dispositions concerning the protection of personal data, we hereby request consent (under Art. 23) to the treatment of common and sensitive data which for the purposes of certification, membership, administration, accounting, related commercial or legal activities and/or for providing assistance, need to be made available to our personnel. Any data relating to racial and ethnic origin, religious, philosophical or other convictions, political opinions, membership of political parties or unions, or of religious, philosophical, political and other associations or organizations, as well as data revealing the state of health and sexual inclination, may be used only with express consent in writing and authorization by the official body responsible for data privacy (Article 26).

In accordance with Art. 13, we inform you that:

a – **Purpose of data treatment:** the data in our possession will be used by our personnel exclusively for processing requests for certification and membership, and for the related administrative, accounting, commercial and legal activities and/or to provide assistance.

Processing of data relating to state of health and sexual inclination will be undertaken in accordance with the general conditions established by the authority responsible for the protection of data privacy no. 1/2008 and later.

b – **Mode of treatment:** Data will be processed principally by electronic means and stored both in electronic and printed form, or other suitable means, in accordance with the minimum security measures set out in the Technical Regulations, Attachment B of the Privacy Code.

c – **Obligation:** the communication of such data is not obligatory;

d – **Consequences of the refusal to provide data or approval of data processing: refusal to provide the required data or to the processing of such data may impede the execution of activities; in this case REGISTRO FIAT ITALIANO and REGISTRO ABARTH decline all responsibility for the non-execution of such activities);**

d – **Access to the content and nature of data:** your data may be communicated to the RFI offices and persons responsible for commercial, administrative, legal activities, as well as the Board of Management and other national and international associations to which **REGISTRO FIAT ITALIANO and REGISTRO ABARTH** belong. In all cases, the data will be made available only when strictly necessary;
